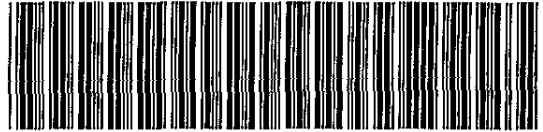

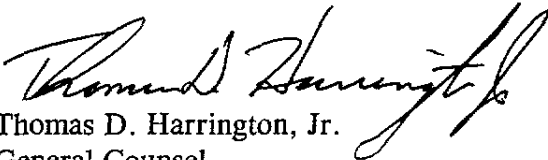

The name and address of the initial registered agent is Thomas D. Harrington, Jr., 3829 Coconut Palm Drive, Tampa, FL 33619.

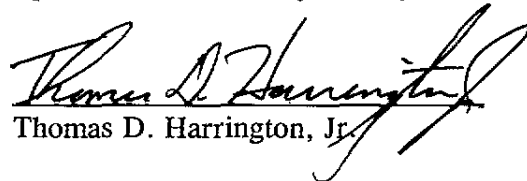

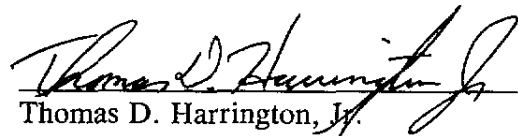
