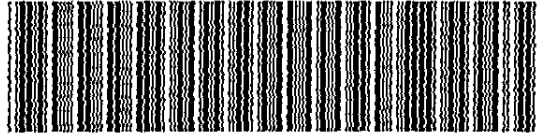

**OF**

**ARTICLE ONE**

The name of this corporation is LANI KAI PROPERTIES, INC. and the mailing address of the corporation shall be 1400 Estero Boulevard, Fort Myers Beach, FL 33931.

**ARTICLE TWO**
