Articles of Incorporation of Snackdaddy Vending, Inc.

THE UNDERSIGNED, acting as the sole Incorporator of Snackdaddy Vending, Inc. ("Corporation") under the Florida Business Corporation Act ("FBCA"), Chapter 607, Florida Statutes, as hereafter amended and modified, hereby adopts the following Articles of Incorporation for the Corporation:

ARTICLE I NAME
