ARTICLES OF INCORPORATION

OF

WOLFE MANAGEMENT CORPORATION

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

- ARTICLE 1. Name. The name of the Corporation is: WOLFE MANAGEMENT CORPORATION.
 - ARTICLE 2. <u>Duration</u>. The duration of the Corporation is perpetual.
