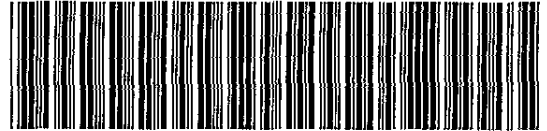



**ARTICLE IV**


