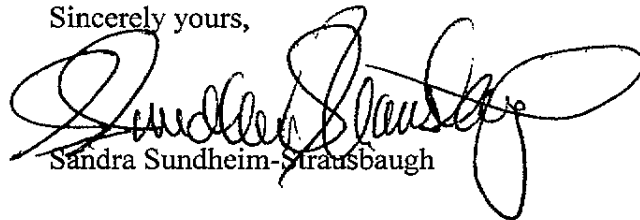

I, the undersigned subscriber to these Articles of Incorporation, do hereby form a corporation for profit under the laws of the State of Florida, as follows:

**ARTICLE I. NAME**

**ARTICLE III. PURPOSE**

**ARTICLE VIII. BY-LAWS**

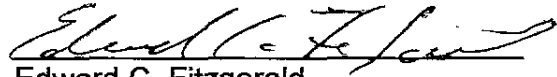
The power to adopt, alter, amend or repeal By-Laws shall be vested in the Shareholders.

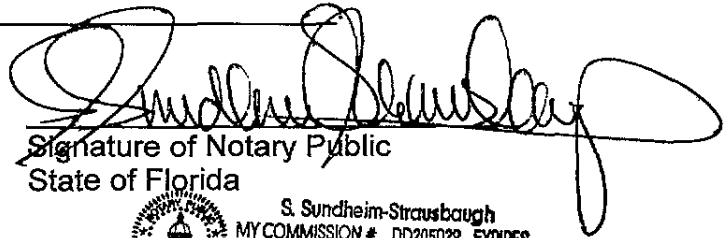
**ARTICLE X. PREEMPTIVE RIGHTS**
