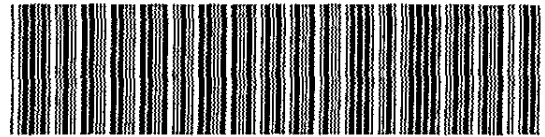

**ARTICLES OF INCORPORATION
T.W.I.C.E. EDUCATIONAL SERVICES, INC.**

The undersigned, acting as incorporator of a Florida Corporation under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such Corporation:

**ARTICLE I
NAME**

The name of the Corporation is **T.W.I.C.E. Educational Services, Inc.**

**ARTICLE II


