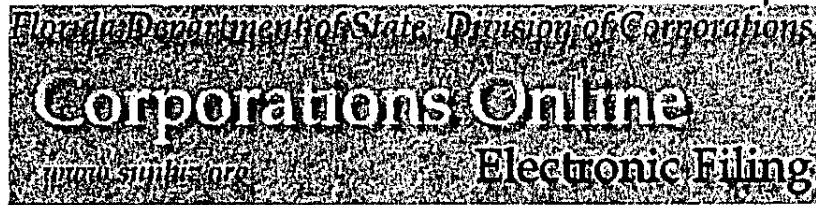

We have been in business since 1987 and we file, on time, every year. I am not really sure what had happened with our second filing for House of Style.net. I am still trying to find out.

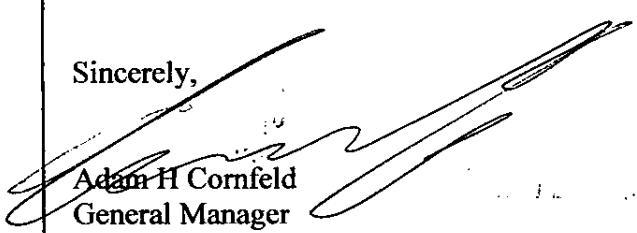
