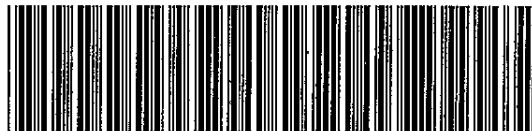



ARTICLES OF INCORPORATION  
OF

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

EFFECTIVE DATE

ARTICLE I

The name of the Corporation ("Corporation") is Home Entertainment Integrators, Inc.

ARTICLE II

The existence of the Corporation shall begin on June 17, 2003.

ARTICLE III

The street address of the principal office of the Corporation is 15260 SW 138 Place, Miami, Florida 33177.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 100 (One Hundred) par value \$.01 per share, all of which shall be Common Shares. 


