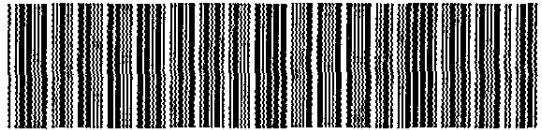

ARTICLES OF INCORPORATION
OF
ONE STOP FUNDING SERVICES, INC.

ARTICLE ONE

The name of the corporation is ONE STOP FUNDING SERVICES, INC.
The principal address of the corporation is: 1964 Ascott Road, N. Palm Beach, Florida 33408.

ARTICLE TWO

The period of its duration is perpetual.

ARTICLE THREE

The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Florida Corporation Act.

ARTICLE FOUR

The aggregate number of shares which the corporation shall have authority to issue is one thousand (1,000) of no par value.
