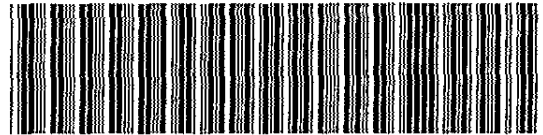

ARTICLE 9.

CUMULATIVE VOTING

At each election for directors every share holder entitled to vote at such election shall have the right to cumulate his votes by signing one candidate as many votes as the number of directors to be elected at this that time multiplied by the number of his shares, or by distributing such votes on the same principle among any number of such candidates.

ARTICLE 10.

PREEMPTIVE RIGHTS

Each holder of the common stock of this Corporation shall have the first right (subject to adjustments to avoid the issuance of fractional shares) to purchase shares of any other securities that this Corporation may issue from time to time, whether or not such shares are presently authorized, including shares from the treasury of this Corporation, in the ratio that the number of shares of common stock held by such shareholder at the time of the issue bears to the total number of shares of common stock who does not exercise it and pay for the stock available for purchase pursuant to such preemptive rights, within (30) days of his receipt of a written notice from this Corporation inviting him to exercise such right.

ARTICLE 11.

IDEMNIFICATION

The Corporation shall indemnify ant officer or director, or any former officer or director, to the full extent permitted by law.

ARTICLE 12.

BYLAWS

The initial Bylaws shall be adopted by the Board of Directors. The power to alter amend or repeal the Bylaws or adopt new Bylaws is vested in the Board of Directors, subject to repeal or change by action of the shareholders.
