ARTICLES OF AMENDMENT OF THE ARTICLES OF INCORPORATION OF VISTA HILL HOLDINGS, INC.

VISTA HILL HOLDINGS, INC., a corporation organized and existing under the laws of the State of Florida (the "Corporation"), in order to amend its Articles of Incorporation in accordance with the requirements of Section 607.1001 et. seq. of the Florida Business Corporation Act, Goes hereby adopt the following Articles of Amendment to its Articles of Incorporation:

ARTICLE I Name

The name of the Corporation is VISTA HILL HOLDINGS, INC. The Articles of Incorporation of the Corporation were filed with the Florida Secretary of State on August 1, 2003.

ARTICLE II Amendment

Article III of the Articles of Incorporation of this Corporation is hereby amended for the purpose of changing the number of Class B Non-Voting Common Stock shares of the Corporation by deleting the existing Article III in its entirety, and substituting the following therefore to wit:

"ARTICLE III CAPITAL STOCK

(a) Authorized Capitalization.

The total number of shares of capital stock authorized to be issued by this Corporation shall be:

500,000 shares of Class A Voting Common Stock, par value \$.01 per share (the "Class A Common Stock");

4,000,000 shares Class B Non-Voting Common Stock, par value \$.01 per share (the "Class B Common Stock")

(b) <u>Paymont for Stock</u>. All or any part of the consideration for the issuance of the capital stock of this Corporation may be in cash, property or labor or services at a fair valuation to

be fixed by the Board of Directors at a meeting called for that purpose, which consideration, in any event, shall not be less than the par value of the shares issued therefor. All stock when issued shall be fully paid and nonassessable.

- (c) <u>Yoting</u>. The voting power of this Corporation shall be vested solely in the Class A Common Stock, including the right to elect all members of the Board of Directors of the Corporation (except as specifically required by the Florida Business Corporation Act) (Chapter 607, *Florida Statutes*) (the "Act"). Holders of shares of Class A Common Stock shall be entitled to one vote for each share of Class A Common Stock. Shares of Class B Common Stock shall not be entitled to any vote on any matters brought before the shareholders for a vote, except as specifically required by the Act. There shall be no cumulative voting in the election of directors.
- (d) <u>Dividends</u>. Any and all dividends are to be shared among the holders of shares of outstanding Class A Common Stock and Class B Common Stock on a share for share basis."

ARTICLE III Date of Adoption

The amendment was duly adopted on <u>September 5</u>, 2014

ARTICLE IV MANNER OF ADOPTION

The amendment was duly approved by the written consent of the required number of shareholders the Corporation entitled to vote on the matter.
