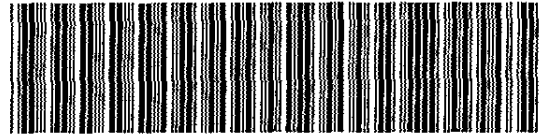

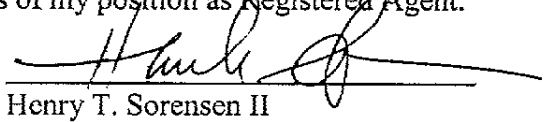
The purpose of the corporation is to engage in the provision of legal services to real estate brokerages and related persons and entities, and the term of the corporation is perpetual.
