THE ARTICLES OF INCORPORATION

1. The name of this corporation is **1-866-JUNK-BE-GONE CORP / MIAMI**, a Florida corporation (the "Corporation").

2. Article IV, of the Articles of Incorporation of **1-866-JUNK-BE-GONE CORP / MIAMI** is hereby deleted in its entirety and replaced as follows:

"ARTICLE IV – SHARES

The corporation is authorized to issue 10,000 shares of stock with a par value of \$1.00 per share."

3. The foregoing amendment was adopted by joint unanimous consent of the directors and shareholders on May 21, 2007.
