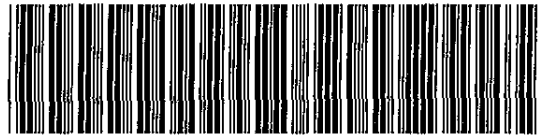

**ARTICLES OF INCORPORATION
OF
DAYTONA AIRCRAFT SERVICES, INC.**

ARTICLE I - NAME OF CORPORATION

The name of this corporation is **DAYTONA AIRCRAFT SERVICES, INC.**

ARTICLE II - PURPOSES

This corporation is organized for the purpose of transacting any or all lawful business pursuant to the provisions of Chapter 607, Florida Statutes.

ARTICLE III - CAPITAL STOCK

The maximum number of shares this corporation is authorized to issue is 7,000 shares of common stock, each having a par value of \$1.00. All common shares shall be identical with each other in every respect and the holders thereof shall be entitled to one vote for each share upon all matters on which shareholders have the right to vote.

ARTICLE IV - PRINCIPAL OFFICE

The street address of the initial principal office of this corporation is 561 Pearl Harbor Drive, Daytona Beach, Florida 32114. The mailing address of the corporation is the same.

ARTICLE V - DURATION

This corporation shall exist perpetually unless sooner dissolved according to law.

ARTICLE VI - REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the corporation is 561 Pearl Harbor Drive Daytona Beach, Florida 32114 and the name of its initial registered agent at such address is JIM TESKI.

ARTICLE VII - INITIAL BOARD OF DIRECTORS
