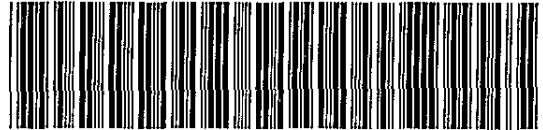

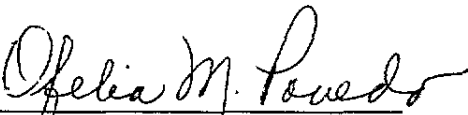

**ARTICLES OF INCORPORATION**

**OF**

**COMPLETE BILLING SERVICES INC.**

The undersigned, subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation under the Laws of the State of Florida.

**ARTICLE I. CORPORATE NAME**

The name of this corporation is: **COMPLETE BILLING SERVICES INC.**

**ARTICLE II. NATURE OF BUSINESS**

The corporation shall have the unlimited power to engage in any activity or business permitted under the Laws of The United States of America and of the State of Florida.

**ARTICLE III. CAPITAL STOCK**

The maximum number of shares of stock that this corporation shall have the authority to issue is One Thousand (1,000) shares of Common Stock, having a par value of One (\$1.00) Dollar each.

**ARTICLE IV. TERM OF EXISTENCE**

The Corporation is to exist perpetually .
