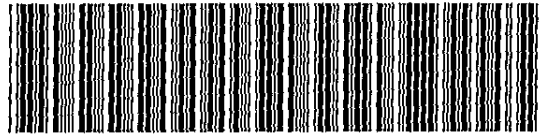

**ARTICLE X – Initial Officers**

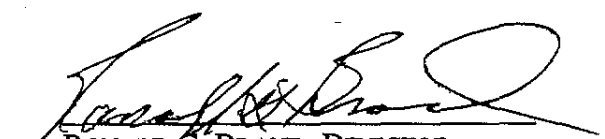
The officers of the corporation shall be amended to read as follows:
