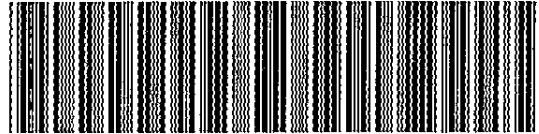

**ARTICLE I**

**NAME AND ADDRESS OF CORPORATION**

**ARTICLE II**

**GENERAL NATURE OF BUSINESS**

This corporation may engage in all forms of lawn care services, landscape fill dirt, and the land excavation services. This corporation may also engage in the retail and wholesale distribution of lawn care and landscape products. This corporation may engage in any other business allied to the lawn care and landscape industry, or any other lawful business permitted by the laws of the state of Florida.

**ARTICLE III**

**CAPITAL STOCK**

The maximum number of common stock shares that this corporation is authorized to issue is Fifty thousand shares, (50,000). Each share shall have a par value of one dollar (\$1.00).

This corporation shall exist perpetually commencing on the date of execution and acknowledgement of these Articles by the state of Florida.


**ARTICLE VI**



