ARTICLES OF INCORPORATION

OF

The undersigned incorporator, for the purposes of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I NAME

The name of the corporation shall be "VILLAGE OF THE CARIBBEAN CULTURES CORP."

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this Corporation is 1401 Dewey Street, Hollywood, FL 33020.

ARTICLE III CAPITAL STOCK

The aggregate number of shares which the Corporation is authorized to issue is six millions (6,000,000) shares Class A of Common Stock, par value \$ 0.001 per share.

The aggregate number of shares which the corporation is authorized to issue is two millions one hundred thousand (2,100,000) shares Class B of Preferred Stock, par value \$2.00 per share non-participating, non-voting, with 10% Fixed Cumulative Dividend payable in Class A of Common Stock (1 Common stock for each 10 preferred stock), convertible within 36 months to 48 months, from the date issued, not before 36 months and not after 48 months, in Class A of Common Stock upon written request by the owner (1 Preferred Stock Class B for 1 Common Stock Class A).

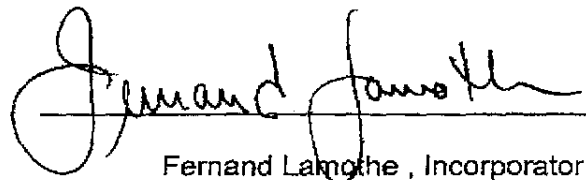

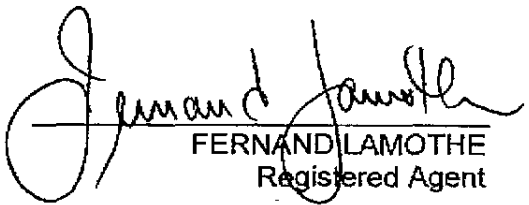
