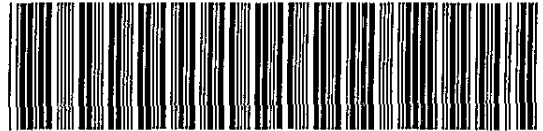

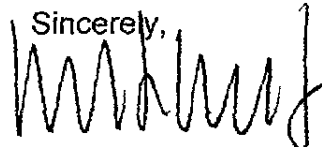

ARTICLE I - NAME OF CORPORATION

The name of the corporation shall be Marine Diesel Service, Inc.

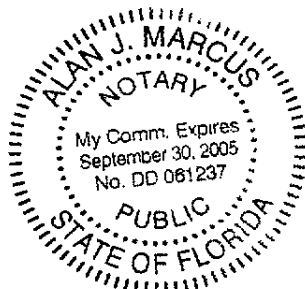

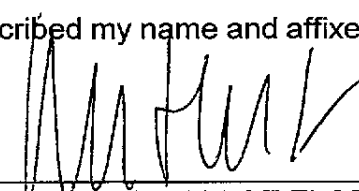
