## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF D'ROY GROUP, INC.

SECRETARY PAY 135

I. Article IV of the Articles of Incorporation of D'ROY GROUP, YNC. is amended to read as follows:

#### ARTICLE IV - CAPITAL STOCK

The amount of authorized capital stock of the corporation shall be \$6,000.00, and shall be divided into two classes of stock. Class A stock shall consist of Three Hundred Thousand (300,000) shares of voting stock with a par value of one cent (\$.01) per share for a total of Three Thousand Dollars (\$3,000.00). Class B stock shall consist of three hundred thousand shares (300,000) of non-voting stock with a par value of one cent (\$.01) per share for a total of Three Thousand Dollars (\$3,000).
