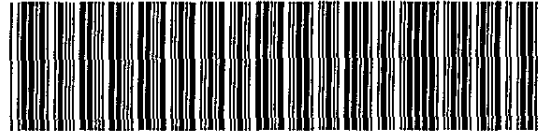

OF

ARTICLE I

The name of the corporation is A-1 SITE PREP, INC.


