

# ARTICLES OF INCORPORATION OF THETA PHARMACEUTICALS, INC. A FLORIDA CORPORATION

The undersigned, acting as Incorporator of Theta Pharmaceuticals, Inc., a Florida corporation (the "Corporation") under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such Corporation:

## **ARTICLE I**

## **NAME**

The name of the Corporation is Theta Pharmaceuticals, Inc., and the street address of the initial principal office of the Corporation is 3620 Park Central Boulevard North, Pompano Beach, FL 33064.

#### ARTICLE II

#### <u>PURPOSE</u>
