## ARTICLES OF INCORPORATION OF MISSION ENVELOPE, INC.

The undersigned, acting as Incorporator of a corporation under the Florida General Corporation Action adopts the following Articles of Incorporation for such corporation:

ARTICLE 1 NAME: The name of the corporation shall be Mission Envelope, Inc.


