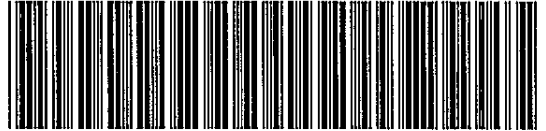

ARTICLES OF INCORPORATION
OF
SEVEN BRIDGES TILE, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I: NAME

The name of the corporation shall be: **SEVEN BRIDGES TILE, INC.**

ARTICLE II: PRINCIPAL OFFICE


