ARTICLE I

Nature and Duration

The name of the Corporation is Connied, Inc. The duration of the Corporation is perpetual. The effective date upon which this Corporation shall come into existence shall be the date these Articles are filed by the Secretary of State.

ARTICLE II

Principal Office

The address of the principal office of the Corporation is 600 Oak Avenue, Sanford, Florida, 32771.

ARTICLE III

Registered Office and Agent

The address of the registered office in the State of Florida is 600 Oak Avenue, in the City of Sanford, County of Seminole. The name of the registered agent at such address is Lacy K. Loar.

ARTICLE IV

Corporate Purposes, Powers and Rights

1. The nature of the business to be conducted or promoted and the purposes of the Corporation are to engage in any lawful act or activity for which corporations may be organized under the Florida Business Corporation Act.
2. In furtherance of its corporate purposes, the Corporation shall have all of the general and specific powers and rights granted to and conferred on a corporation by the Florida Business Corporation Act.

Capital Stock

The Corporation shall indemnify any Incorporator, officer or director, or any former Incorporator, officer or director, to the full extent permitted by law.

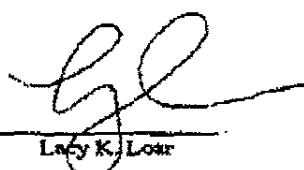
ARTICLE XI

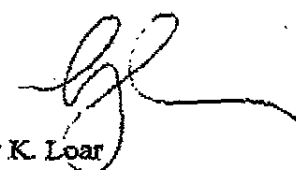
REGISTERED AGENT CERTIFICATE
