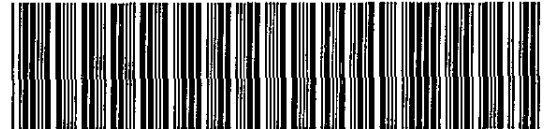

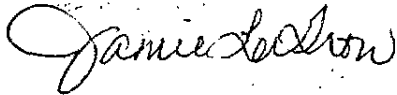

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I: NAME

The name of the corporation is DB Davis Homes, Inc.

ARTICLE II: PRINCIPAL OFFICE

The principal office is 315 South Huckleberry Lake Drive, Sebring, Florida 33875.

ARTICLE III: DURATION

The duration of the corporation is perpetual.

ARTICLE IV: PURPOSE

The name and address of the incorporator of these Articles of Incorporation is David B. Davis, 315 South Huckleberry Lake Drive, Sebring, Florida 33875.

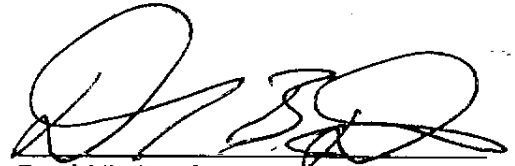
