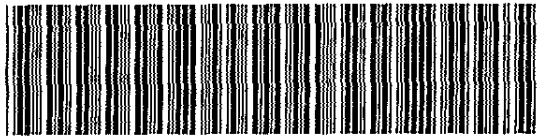

Article I – Corporate Name

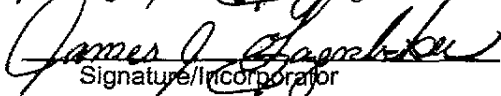
Article VIII – Effective Date of Incorporation
