The name of the corporation is Ampersand & Ellipsis, Inc., (hereinafter called "Corporation").

ARTICLE I

The address of the principal office and the mailing address of the Corporation is 2255 SW 28th Street, Miami, Florida 33133.

ARTICLE II

(a) The capital stock authorized, the par value thereof, and the characteristics of such stock shall be as follows:

(b) The Corporation shall hold a special meeting of shareholders:

(1) On call of the Board of Directors or persons authorized to do so by the Corporation's Bylaws; or

(2) If the holders of not less than 50 percent of all votes entitled to be cast on any issue proposed to be considered at the proposed special meeting sign, date, and deliver to the Corporation's secretary one or more written demands for the meeting describing the purpose or purposes for which it is to be held.

ARTICLE III

The street address of the Corporation's initial registered office in the State of Florida is 526 East Park Avenue, City of Tallahassee, County of Leon, and the name of its initial registered agent at such office is NRAI Services, Inc.

ARTICLE IV

The Board of Directors of the Corporation shall consist of at least one director, with the exact number to be fixed from time to time in the manner provided in the Corporation's Bylaws. The number of directors constituting the initial Board of Directors is one, and the
