ARTICLES OF INCORPORATION

OF

DIVERSE REALTY, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME AND ADDRESS

The name of the corporation is **DIVERSE REALTY**, **INC.**, and its initial post office address and its principal office for conducting business is: 1395 Third Street South, Naples, Florida 34102.

ARTICLE II - DURATION

This corporation shall have perpetual existence, commencing on the date filed with the Department of State for the State of Florida.
