ARTICLES OF INCORPORATION
OF

ARTICLE I – NAME & ADDRESS

The name of this corporation is STURGEON CONSTRUCTION, INC. The mailing address of the corporation is 11108 Stafford Lane, Riverview, Florida 33569.

The name and address of the person signing these Articles is Brian M. Bursa, 410 South Ware Boulevard, Suite 1100, Tampa, Florida 33619.

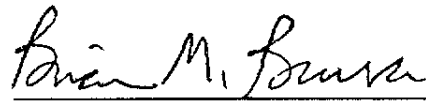
ARTICLE VII – INDEMNIFICATION

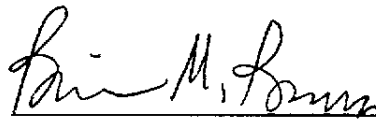
