The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

**ARTICLE ONE**

**NAME**

The name of this corporation is **J<sup>3</sup> SOUTHEASTERN CORP.**, and its principal place of business is 12101 N.W. 98<sup>TH</sup> Avenue, Bay 8, Hialeah Gardens, FL 33018.

**ARTICLE TWO**

**DURATION**

The duration of the corporation is perpetual.

**ARTICLE THREE**

**PURPOSES**

The general purpose for which the corporation is organized are:

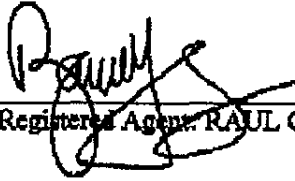
