ARTICLES OF INCORPORATION

OF

Brevard Flooring Services, Inc.

ARTICLE I - NAME

The name of the corporation is Brevard Flooring Services, Inc. at 113 5th Avenue, Indialantic, FL 32903 (Principal Office of Registered Agent).

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing at the time of filing these articles with the Secretary of State of the State of Florida.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any of all lawful business.

ARTICLE IV - CAPITAL STOCK
