**ARTICLES OF INCORPORATION
OF

The Undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME

The name of the Corporation is: **Gold Key Construction, Inc.**

ARTICLE II - ADDRESS OF THE PRINCIPAL OFFICE

Located in Palm Beach County, the principal place of business and street address of this corporation shall be: **2107 SW 15th Street - Boynton Beach, Florida 33426**

ARTICLE III - PURPOSE

The purpose of the corporation and the general nature of the business to be transacted shall be in construction and any other lawful business. 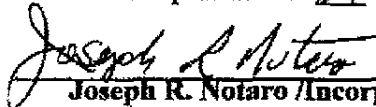

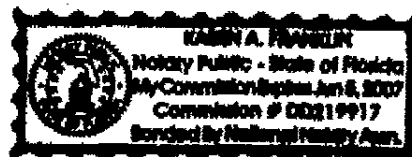
