ARTICLES OF INCORPORATION OF CHUCK'S WINDOW REPAIR, INC.

Article I - Name

The name of this corporation is CHUCK'S WINDOW REPAIR, INC. The principals office of the corporation is: 1395 Buckles Road, Pierson, FL 32180, and the mailing address of the corporation is: P.O. Box 250854, Holly Hill, FL 32125.

Article II - Duration

This corporation shall have perpetual existence.

Article III - Purposes
