**ARTICLES OF INCORPORATION
OF

The corporation shall have authority to issue Ten Thousand (10,000) shares of Common Stock, One Cent (\$0.01) par value per share.


ARTICLE IV

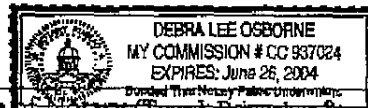
