
ARTICLE IX - DURATION

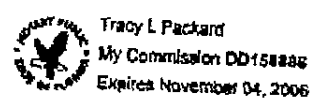


