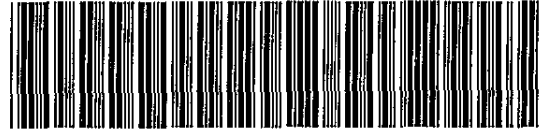

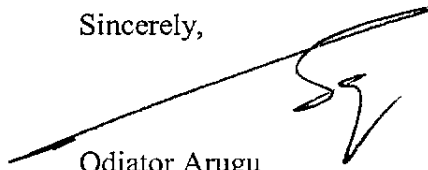

ARTICLE I

Name and Duration

The name of the Corporation is Callins Investigations, P.A. The duration of the Corporation is perpetual. The effective date upon which this Corporation shall come into existence shall be the date these Articles are filed by the Secretary of State.

ARTICLE II

Principal Office and Mailing Address

The address of the principal office of the Corporation is 3525 W. Lake Mary Boulevard, Suite 308-A, Lake Mary, Florida 32746. The mailing address of the Corporation is Post Office Box 950180, Lake Mary, Florida 32795.

ARTICLE III

Registered Office and Agent

The address of the registered office in the State of Florida is 1999 W. Colonial Drive, Suite 213, in the City of Orlando, County of Orange. The name of the registered agent at such address is Odiator Arugu.

ARTICLE IV

Corporate Purposes, Powers and Rights

1. The nature of the business to be conducted or promoted and the purposes of the Corporation are to engage in the rendition of professional private investigation services such as, but not limited to, surveillance, recorded statement, activity checks, background investigations, any lawful act or activity for which professional corporations may be organized under the Florida Professional Service Corporation and Limited Liability Company Act.

2. In furtherance of its corporate purposes, the Corporation shall have all of the general and specific powers and rights granted to and conferred on a professional corporation by the Florida Professional Service Corporation and Limited Liability Company Act.

ARTICLE V

Capital Stock

1. The total number of shares of capital stock which the Corporation has the authority to issue is three hundred (300) shares of Common Stock ("Common Stock") One Dollar (\$1.00) par value per share.

Board of Directors

1. The number of members of the Board of Directors may be increased or diminished from time to time by the Bylaws; provided, however, there shall never be less than one. Each director shall serve until the next annual meeting of shareholders.

2. If any vacancy occurs in the Board of Directors during a term, the remaining directors, by affirmative vote of a majority thereof, may elect a director to fill the vacancy until the next annual meeting of shareholders.

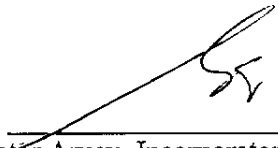
ARTICLE IX
