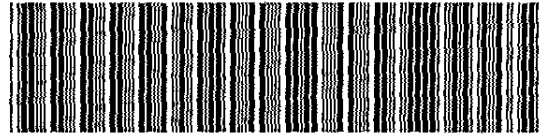

ARTICLE I

The name of this corporation is: **COTTON'S AIR CONDITIONING, INC.,**

ARTICLE II

The term of existence of the corporation is perpetual.

ARTICLE III

ARTICLE IV - CAPITAL STOCK
