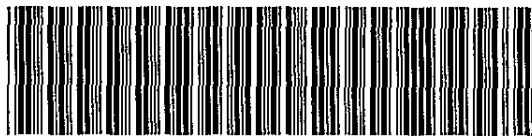

FIRST: To change:

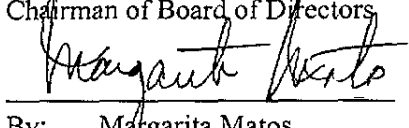
