The undersigned incorporators, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt the following Articles of Incorporation.

ARTICLE I NAME

The name of the corporation shall be: Francis Siding, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business of this corporation shall be: 2531 Glenwood Drive, Edgewater, Florida 32141

ARTICLE III PURPOSE OR PURPOSES

The purpose or purposes for which the corporation is organized are to engage in construction and sub-contracting under licensed contractors. The repair and /or replacement of existing damaged or the enlargement of existing home structures.
