ARTICLES OF INCORPORATIONOFEDWARD J. AHRENS, INC.FILED STATE

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

Article 1. Name. The name of the Corporation shall be: EDWARD J. AHRENS, INC.

Article 2. Address. The address of the principal office and mailing address of the Corporation is: 420 Park Circle South, St. Petersburg, Florida 33707.

Article 3. Authorized Shares. The Corporation is authorized to issue one class of shares, which shall be called common shares. Common shares shall have unlimited voting rights and shall be entitled to receive the net assets of the Corporation upon dissolution. The Corporation is authorized to issue one hundred (100) common shares. Such shares shall have a par value of One Dollar (\$1) per share.

Article 4. Initial Registered Office and Agent. The street address of the initial Registered Office of the Corporation is 420 Park Circle South, St. Petersburg, Florida 33707, and the name of its initial Registered Agent at that address is EDWARD J. AHRENS.

Article 5. Initial Board of Directors. The number of Directors constituting the initial Board of Directors is one (1). The number of Directors may be increased or decreased from time to time in accordance with the Bylaws but shall never be less than one (1). The name and address of the initial Director of the Corporation is as follows: EDWARD J. AHRENS, 420 Park Circle South, St. Petersburg, Florida 33707.

Article 6. Incorporators. The name and address of the Incorporator is as follows: EDWARD J. AHRENS, 420 Park Circle South, St. Petersburg, Florida 33707.

Article 7. Amendment. The Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation or any amendment to them, and any right conferred upon the Shareholders is subject to this reservation.

Article 8. Indemnification. The Corporation shall indemnify each Officer and Director, including former Officers and Directors, to the full extent permitted by law.
