ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME & ADDRESS

The name of this Corporation is All Square Siding, Inc. The principal office, if known, or the mailing address of the Corporation is Post Office Box 382, Umatilla, Florida 32784.

ARTICLE II - DURATION
