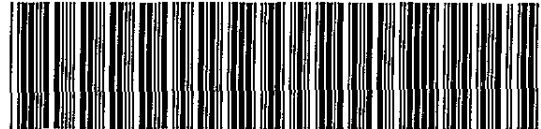

**ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME

The name of this Corporation is **E.J. SPRINKLER SYSTEMS, INC.**

ARTICLE II - DURATION

This Corporation shall have perpetual existence.

ARTICLE III - PURPOSE
