ARTICLES OF INCORPORATION

OF

WORTMAN CONSTRUCTION, CORP.

The undersigned, for the purpose of forming a corporation under the provisions of the FLORIDA GENERAL CORPORATION ACT, do hereby adopt the following Articles of Incorporation:

ARTICLE I

The name of the corporation is WORTMAN CONSTRUCTION, CORP.

ARTICLE II

The duration of the corporation is perpetual.

ARTICLE III

The corporation may engage in the operation of an enterprise known as a general contractor service in connection with the building or maintenance of any property or to enter into any other. business activity authorized under the laws of the State of FLORIDA or of the laws of the United States.
