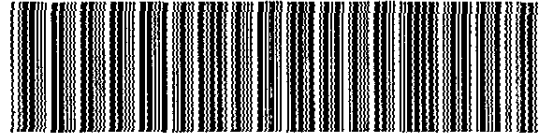


1. I am the owner and sole stockholder of Kasa International Realty, Inc., a Florida Corporation that was dissolved due to non-filing of Annual Report.

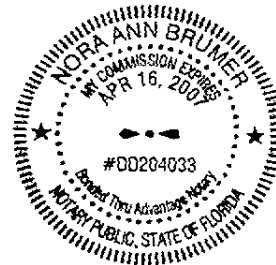




