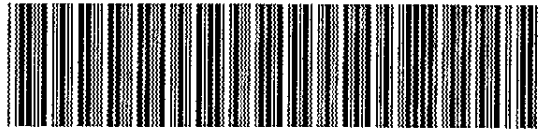

The undersigned, acting as the Incorporator of a corporation under Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation.

ARTICLE I – NAME

The name of the corporation shall be PERFECTION WOODWORK, INC.

ARTICLE II – PRINCIPAL OFFICE

The principal place of business/ mailing address is 1015 Tivoli Lane, Naples, FL 34104.

ARTICLE III – PURPOSE

The purposes for which the corporation is organized are to engage in woodworking as well as any other activity or business permitted under the laws of the United States and Florida.

ARTICLE IV – SHARES

Number: The aggregate number of shares that the corporation shall have the authority to issue is 7,500 shares, all of which shall be common shares.

Voting Rights: Each of these shares will entitle the holder to one (1) vote per share.

Par Value: Each share shall have a stated par value of \$0.01.

Dividends: The holders of the outstanding shares shall be entitled to receive, when and as declared by the Board of Directors, dividends payable either in cash, in property, or in shares of the stock of the corporation.

ARTICLE V – INITIAL DIRECTORS

The corporation shall initially have one (1) director. The number of directors may be amended or modified through the corporation's bylaws. The name and address of the initial director is as follows:
