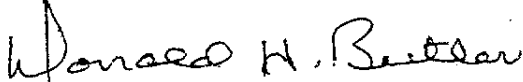

ARTICLES OF INCORPORATION OF ***Pro-Clean of Jacksonville, Inc.***

ARTICLE I. NAME

The name of the corporation is:
