



ARTICLES OF INCORPORATION OF Vilama Unisex Beauty Salon, Inc.

ARTICLE 1 - NAME AND ADDRESS

The name of the corporation shall be *Vilama Unisex Beauty Salon*, *Inc.*, with its place of business at 2325 N.E. 5th Avenue, Pompano Beach, Florida 33064.

ARTICLE II - CORPORATE NATURE

This corporation is organized pursuant to the Corporations For Profit Law of the State of Florida, set forth under the Florida Business Corporation Act of the Florida Statues.

ARTICLE III - PURPOSE
