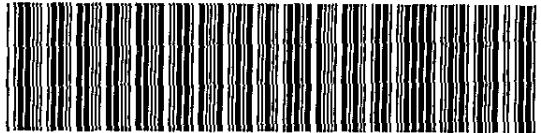



The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE-ONE

NAME

The Corporate name is **PEBBLE CREEK VETERINARY MEDICAL GROUP, INC.**

ARTICLE-TWO

REGISTERED OFFICE

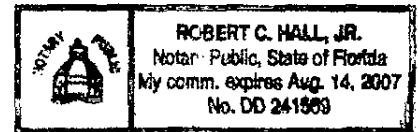
